

D-Link Reports Fourth Quarter 2023 Financial Results

Taipei, February 27, 2024- D-Link today announced its net revenue of NT\$3,710 million for the fourth quarter 2023, a decrease of 16.1% YoY; Gross profit was NT\$750 million, a decrease of 44.7% YoY; D-Link's 4Q23 operating loss was reported at NT\$86 million. D-Link's fourth quarter net income was NT\$56 million, net income attributable to owners of parent was NT\$28 million, and EPS was NT\$0.05.

With respect to 4Q23 consolidated revenue by product category, Switch & Security products accounted for 44% of sales revenue, followed by Wireless & IoT at 14%, Mobile & Broadband at 12%, and Others at 30%. From a geographic perspective, 4Q23 revenue contribution from Europe and America were 27% and 8% respectively, and from Asia Pacific& Others was 65%.

Note: The Company commenced controlling Cameo Communications, Inc. as a subsidiary on April 1, 2023.
